Project status	Project idea, Concept		
Project description	The goal of the project is the construction of a new building of the Health Center to improve the quality and scope of health services in the municipality of Zepce. Currently, the Health center functions in two separate locations: the central facility and the inpatient and three field clinics. The inpatient facility, which houses the Emergency Medical Service, gynecology, part of the laboratory, the morgue and palliative care, is in extremely poor condition (a prefabricated facility built in 1978). With the construction of a new Health center facility, all services would be in one facility, which would simplify the provision of health care. Also, the new facility

	would be built according to prescribed standards, which would improve the working conditions of employees, but also improve the quality and scope of health services. The Health center provides primary health care services to 30,219 inhabitants that live in the municipality of Zepce, and part of secondary health care. The space where health care is provided, unconditioned, insufficient and energy inefficient. Considering the age of the buildings and the lack of space, the adaptation of the existing buildings is not economically profitable.
