	Project part A, for which the budget provides 300,000 EUR gross: 1.Bungalow zone for boarding houses; 2.Museum zone; 3.Park Zone – Forests; 4.Access road		
	Project Part A includes the public part of the project content that has not yet been		
	defined by an architectural and horticultural solution. This part of the project will be		
	developed later.

	in this area who remain uncared for and need health care, assistance, treatment, etc. because their children are in Austria, Switzerland, Germany, Croatia, Slovenia, etc. Among other things, older people who would be in the Nursing home can plant and		
	cultivate their own piece of garden, care for domestic animals, and enjoy therapeutic amenities.
