









WELCOME TO ŽEPČE






Žepče is located on one of the vital roads in central Bosnia connecting Eastern Europe and the Adriatic coast (M-17 highway Bos. Šamac – Sarajevo – Mostar and Ploče – Sarajevo – Šamac – Budapest railway line) and along the highway M-17.1. Žepče – Zavidovići.

Doing business in the municipality of Žepče means access for export to the market of close to 600 million consumers without customs duties (Free Trade Agreements of BiH: Central European Free Trade Agreement (CEFTA): Albania, Serbia, Moldova, Macedonia, CG, UNMIK/Kosovo; Turkey; Stabilisation and Association Agreement; European Free Trade Agreement (EFTA): Norway, Switzerland, Iceland, Lichtenstein).

The municipal administration in Žepče decided to take a proactive approach in creating a favorable business environment for the development of entrepreneurship, thus creating favorable conditions for easier investment in the municipality of Žepče. The opening of new production companies especially in the field of metal and textile industry resulted in a positive trend of continuous decrease in imports in the period from 2018 to 2020. Exports have seen an increase from 2016 to 2019, with a slight decrease in 2020, caused by the coronavirus pandemic. In 2021, import and export increased compared to 2020.


Competitive advantages

The economic strength of the municipality of Žepče is based on 561 small and medium-sized enterprises, mostly in the construction, wood, metal, and textile industries, and 510 crafts where catering and trade are the most represented. The most important economic activities are metal, wood, textile and construction industries where exports are constantly increasing, and traffic and trade, which generate 70% of total revenue. A significant place is also occupied by agriculture.

Major markets and trends

Total exports in 2021 amounted to 92.5 million KM (around 47.2 million EUR) to the markets of 27 different countries with coverage of export by import of 105.48 %. The leading export markets for the economy of the municipality of Žepče are Czech Republic, Germany, France, Slovenia, Austria, Croatia, Italy, Norway, Serbia and the Netherlands. The export is dominated by products from the metalworking and textile industries.

Metalworking

In view of the activities carried out by economic companies in metalworking, they can be classified as the production category of finished metal products, except machinery and equipment. The metal processing sector offers significant investment opportunities in the field of establishing accreditation, attestation and certification centers for welders and welding processes. Metalworkers from Žepče are interested in finding intermediaries for the products and services of micro and small companies for foreign markets and establishing partnerships. Advantages strategic competition are flexibility, i.e., accepting smaller, specific jobs according to special customer requirements, high reaction speed, achieving the same quality at a lower price, diversifying supply and expanding to other parts of the value chain, investing in technologies and software, strategic partners abroad, a smaller share of the workforce in the price of the total product.

Wood processing

Number of companies: 40 companies and 6 trades

Investment opportunities are reflected in the availability of a larger amount of biomass from wood waste in the area of Žepče, which can be used in the development of the production of briguettes and highly priced white eco-pellets. On an annual basis, it is estimated that about 35,000 - 40,000 tons of wood waste in the area of Žepče are unused. The combination of rich forest resources and experienced workforce indicates a favorable business opportunity in the manufacture of wooden floors, furniture, and furniture parts. Local wood processors are interested in accessing more modern production technologies and design services of the final product. Key advantages of leaders: technology that enables adaptation to new trends and demands of customers, more efficient organization of work thanks to capacities, many years of experience in the sector, high quality of products, etc.

Textile industry

One of the most important industries in the municipality of Žepče is the processing of textiles, which has a long tradition. During the pre-war period, the most important textile producer in Žepče was the company ILZO, from which, based on the available qualified workforce and knowhow, a number of private companies in the field of textile and leather processing were created. A special importance in the textile processing sector is the production of HTZ equipment, which has a long tradition in Žepče. The textile sector offers investment opportunities through the development of strategic partnerships, and assistance in building and placing its own production lines abroad.

Agriculture

Total area of agricultural land: 4.470 ha According to estimates, of the total population and available agricultural land, each inhabitant accounts for 0.20 ha of agricultural land. In the area of the municipality of Žepče, ending on 31.12.2021. there was a total of 125 active crafts in the field of agriculture. Subsectors in which companies and crafts operate in the field of agriculture are viticulture, farming, fruit and vegetable growing, raspberry growing, poultry farming, greenhouse production, pig breeding, dairy farming, sheep breeding, beekeeping, trade of agricultural supplies. Some companies in the field of agriculture are export-oriented and export 4% of agricultural products from total exports from Žepče.

Significant investments in the last five years

Significant investors in the last 5 years from the municipality of Žepče are: "Marić Projekti Ltd." (company for the production of PVC joinery and Ceramix salon of ceramics, sanitary ware, and parquet), "Armani Trade Ltd." (nursing homehotel, business center), "California Ltd." (swimming pool complex, restaurant, ceremony hall), "Eagle Technology Ltd." (additional production hall), "Tisa Komerc Ltd." (office building), "Badnjar Ltd." (business-production building), "Fastco Ltd." (business facility for the production of upholstered furniture), "A.M. Interstil Ltd." (furniture and white goods salon), "Vin metal Ltd." (new business unit Katava Oil – gas station, coffee bar and market), etc.

The municipality of Žepče participates in subsidizing the initial investment costs for production and business facilities that are being built on the territory of the Municipality of Žepče.

- The amount of annuity per m² of usable area the building and
- The amount of fee for the arrangement of the construction land per m² of usable area of the building to be built on the city building land in the industrial zone "Polja" is reduced by **75% of the calculated amount**
- The amount of annuity per m² of usable area the building and
- The amount of fee for the arrangement of the construction land per m² of usable area of the building to be built on the city building land and other building land on the territory of the municipality of Žepče is reduced from the calculated amount as follows:
- 75% for companies employing over 200 workers,
- 60% for companies employing 100-200 workers,
- 50% for companies employing 50-100 workers,
- 40% for companies employing 30-50 workers,
- 30% for companies employing up to 30 workers

The investor of the production – business facility is obliged to prove the employment of workers within two years from the issuance of the usage permit. Otherwise, he is obliged to pay the rent for the arrangement of the construction land in full amount as determined in Articles 38 and 49 of the Decision on Construction Land (Official Gazette of the Municipality of Žepče, No. 7/10).

Textile industry



Prevent Specials d.o.o. - Prevent Specials - domestic investor, employing 250 workers in 2021. At the plant in the Industrial zone "Polja", production of leather and textile upholstery for the first installation of seats in passenger vehicles of the world's leading brands, brand Audi and VW is organized.



Jifeng Automotive Interior – Jifeng Automotive Interior BH Ltd. employing 204 workers in 2021. It is engaged in the production of headrests and armrests for the automotive industry (pillows and handrails).



Neveon Bosnia d.o.o. - The Austrian company employs 89 workers in 2021. The company produces upholstery and seats for the planes of the world's largest airlines.



Elchy Tex d.o.o. - domestic investor that has been operating since 2007, employing 107 workers in 2021. The main activity of the company is the production of industrial textile products, protective work clothes and fashion confectionery.



Antilop d.o.o. Žepče – domestic investor, in 2021 they employed 52 workers. They are engaged in the production of clothing, footwear and HTZ equipment.

Metal industry



Sliško d.o.o. – is the only BiH manufacturer of tank vehicles and semi-tanks for petroleum products for the markets of BiH, Croatia and Serbia, employing 79 workers in 2021. They also provide services (production of parts and vessels) for companies from Germany, Slovenia, and the Netherlands.



Profil-Isolation d.o.o. - built a production plant for prefabricated panels, where 43 workers worked in 2020. The main activity of Profil-Isolation is the production of ducts and spiro pipes for ventilation, air conditioning and heating, from pre-insulated polyurethane panels. They are engaged in the production and installation of insulation for pipelines, and with the opening of a new hall they also started the work of assembling panels and other facade works.



Tisakomerc d.o.o. - based in Donja Golubinja, employing 63 workers in 2021. In their company they have wood processing, trade in technical materials for the needs of manufacturers of upholstered, panel and solid furniture, trade in all types and qualities of screw goods, and production of tools for aluminum and PVC joinery made of metal and plastic.





Eagle Technology d.o.o. - A Norwegian company that employs 47 workers in 2021. It is engaged with the production of specialized machines for the oil, marine and other industries.



Elmont d.o.o. – domestic investor employing 41 workers in 2021. It operates in the manufacture, installation, and maintenance of all types of metal structures, various types of tanks and reservoirs, facade and roofing works, aluminum locksmith, and advertising elements.

Wood industry



Budo-Export d.o.o. – company founded in 1974, employing 170 workers in 2021. With the development of technologies and modernization, it slowly over time grew into a large enterprise for the production of panels and elements for massive furniture and the production of briquettes.

The company owns its own fleet, its own drying facilities, closed hall, conditioning halls, covered storage space and business and production space.

Prograd Holz d.o.o. - domestic investor, employing 55 workers in 2021. It is engaged in the production of top-quality wooden joinery, furniture, kitchens, and other wood products that are mostly placed on the market of European countries.

Trade



JasminM d.o.o. – a company founded in 1999 with headquarters in Ljeskovica, employing 75 workers in 2021. It is engaged in wholesale and retail trade, accessories and parts for motor vehicles, production, and services. Authorized distributors of the world's leading manufacturers of construction equipment, propulsion systems and hydraulic component. In the coming period, they plan to achieve the production of their own product in the field of agricultural machinery.



Armani Trade d.o.o. - company founded in 1994 as a wholesale and soon a retail store, employing 81 workers in 2021. The company includes 4 service facilities and 4 business centers. 
